

Schedule 1: Consent to Publish for Contributors to Conference Proceedings

The Consent to Publish form ensures that the Publisher has the author's permission to publish the Work. By signing this form, the Author agrees to the terms outlined herein, which forms a binding agreement between the Author and the Publisher (the "**Agreement**").

1. The Author hereby grants to the Publisher the transferable, exclusive right for the full term of copyright and any renewals or extensions, to reproduce, publish, make available and distribute the Contribution and its content (including any adaptation of it such as summaries, extracts, translations) in all languages and forms throughout the world whether now known or hereafter devised, including but not limited to online digital volume form, printed volume form and in other media including microfiche, CD-ROM, on-line electronic networks, electronic or paper-based document delivery services and other suitable media for publication of information contained in the Contribution, and including the exclusive right to license third parties to exercise all or any of such rights.
2. The Author retains the right to re-use the Contribution or parts of it in any way permitted under the Creative Commons Licence in clause 2 without charge and subject only to ensuring that the publication by the Publisher is properly credited and that the relevant copyright notice is repeated verbatim.
3. Subject to the Conference Organiser's payment of the applicable open access publishing fee, the entire Work and consequently, the Contribution may be published on an Open Access Basis under the terms of the Creative Commons [(CC-BY-NC], as updated from time to time ("**Creative Commons Licence**"). For ease of reference, a copy of the current version of the Creative Commons Licence (version 4.0) can be found at [<https://creativecommons.org/licenses/by-nc-nd/4.0/>]. Publishing on an "**Open Access Basis**" means that the Publishers will make the Contribution freely available online under the access and use licence specified under the Creative Commons Licence with no subscription fee or article-pay-to-view fee or any other form of access fee or any publication embargo being applied. If, at the time of delivery of the final manuscript, the Conference Organiser is unable to arrange the payment of the open access publishing fee, the Publishers may choose to, at its absolute discretion, to continue to publish the Work according to their standard publishing terms under this Agreement but will have no obligation to make the Work or Contribution available on an Open Access Basis.
4. The Author warrants that:
 - (a) All persons who have a reasonable claim to authorship are named in the Contribution as co-authors, including the party signing this Agreement. The Author (and co-authors, if any) has not fabricated or misappropriated anyone's identity;
 - (b) The Author is the legal and beneficial owner without encumbrances of the copyright in the Contribution or, to the extent that the Author is not, the Author has obtained all necessary permissions to include material in the Contribution that is owned and held in copyright by a third party, which shall include but is not limited to any proprietary text, illustration, table or other material, including data, audio, video, film stills, screenshots, musical notation and any supplemental material;

- (c) The Author has full power and authority to make this Agreement (including the rights granted to the Publisher) and are not in breach of any law or other agreement in entering into it. If the Contribution has more than one author, the co-author(s) have agreed to be named. The party signing this Agreement is authorised by all such co-authors to sign this Agreement as agent on their behalf, and determine the priority of copyright assertion and the order of names in the publication of the Contribution;
 - (d) The Contribution is original to the Author (except for material in the public domain, and any third-party copyright material included with written permission of the copyright owners in compliance with this Agreement), the Contribution has not previously been published in any form and it does not violate or infringe any existing copyright, moral rights, other intellectual property rights or licence, or any other right of any person or party; and
 - (e) The Contribution contains nothing defamatory, maliciously false, injurious, obscene, in contempt of court, which constitutes a misuse of private information or breach of confidence, or otherwise unlawful or that could reasonably be expected to result in liability for the Author or the Publisher; and
 - (f) All statements in the Contribution purporting to be facts are, to the best of the Author's knowledge and belief, true, complete and not misleading.
5. The Author shall indemnify and hold harmless the Publisher, its affiliates and the Conference Organiser against loss, injury, costs, and expenses, including legal and professional costs or expenses properly incurred and any financial remedies paid by the Publisher, arising from a third party claim related to alleged facts or circumstances which, if true, would constitute a breach of the warranties or representations provided by the Author under clause 0. This indemnity does not apply to any indirect losses suffered by the Publisher or any liability for claims caused solely by the acts or omissions of the Publisher.
6. The Author shall promptly inform the Publisher of any claim, demand, or suit made against the Author in connection with the Contribution and shall make no response to or settlement or admission in relation to any such claim without the consent of the Publisher. The Publisher shall retain the right to defend any such claim (including a claim pursuant to clause 5 for which an indemnity obligation arises) or shall, if the Publisher deems appropriate, make a settlement on any such claim, at the Publisher's own discretion, and the Author shall co-operate fully in defence of any such claim.
7. If at any point whether before or after the publication of the Work, the Publisher reasonably considers that the Contribution should be retracted or removed from its website or the Work on the advice of its advisors, for example, because of a breach of the Author's warranties, the Publisher may decline to publish the Contribution or retract or withdraw the published Contribution.
8. Each party to this Agreement irrevocably agrees that this Agreement will be subject to and will be interpreted in all respects in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the Courts of England and Wales.
